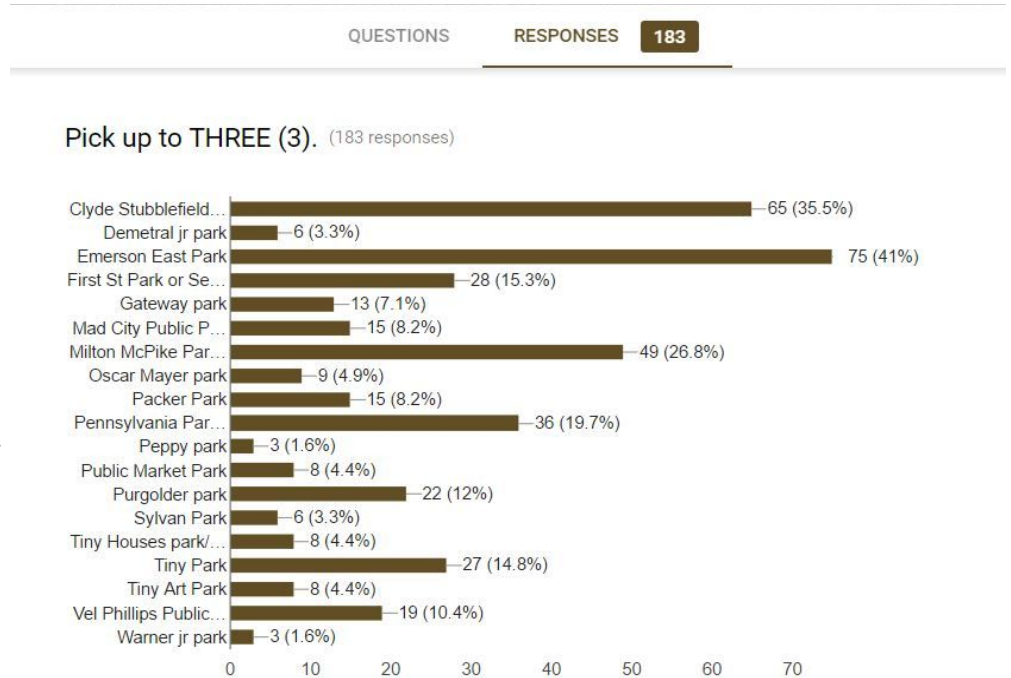
## EENA Social Report, Amanda Duesterbeck
